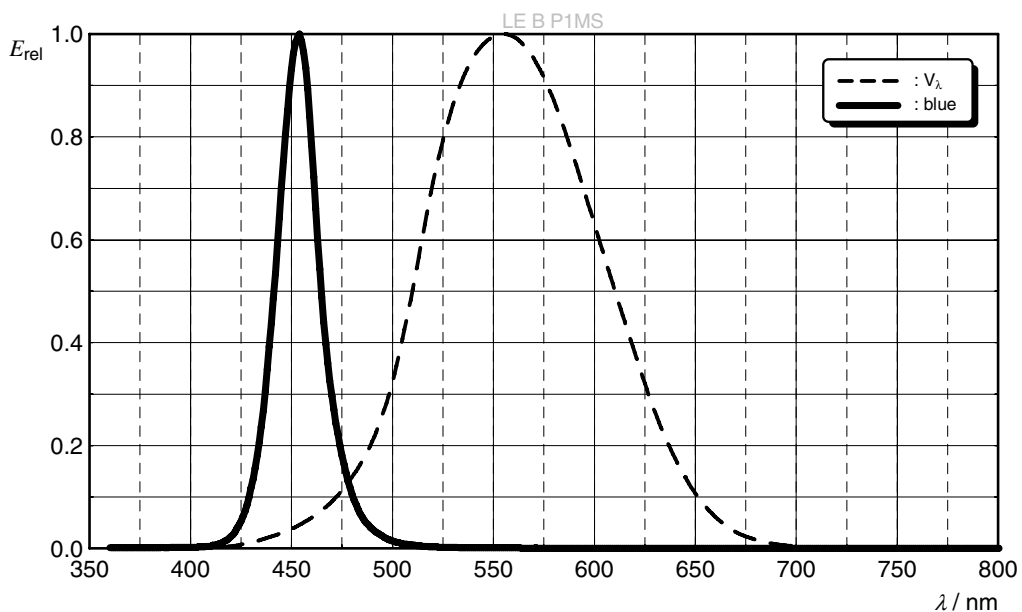

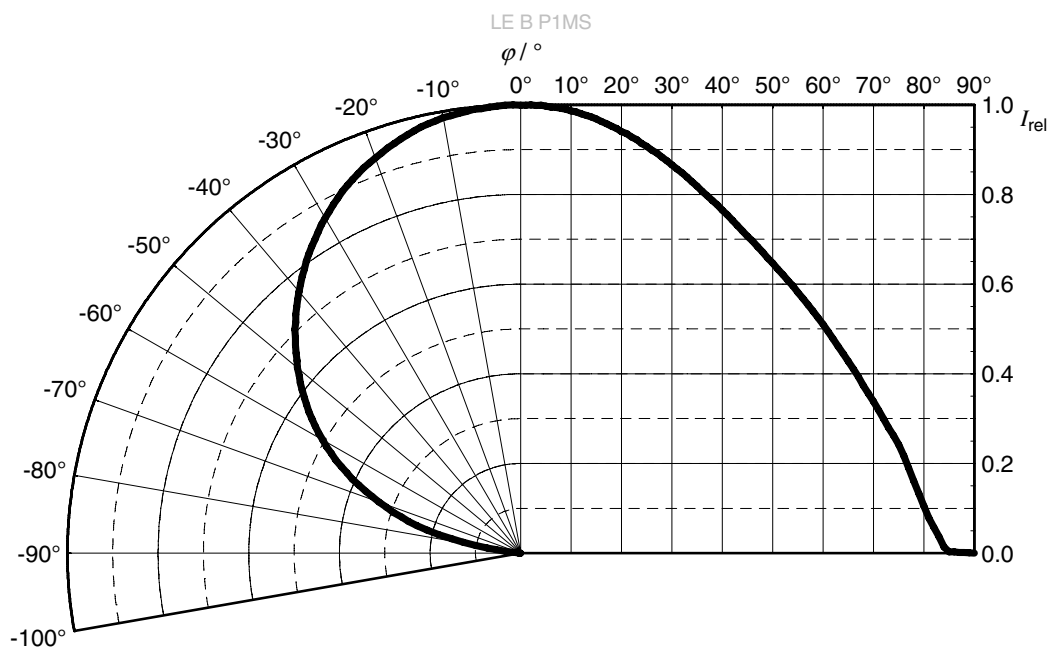

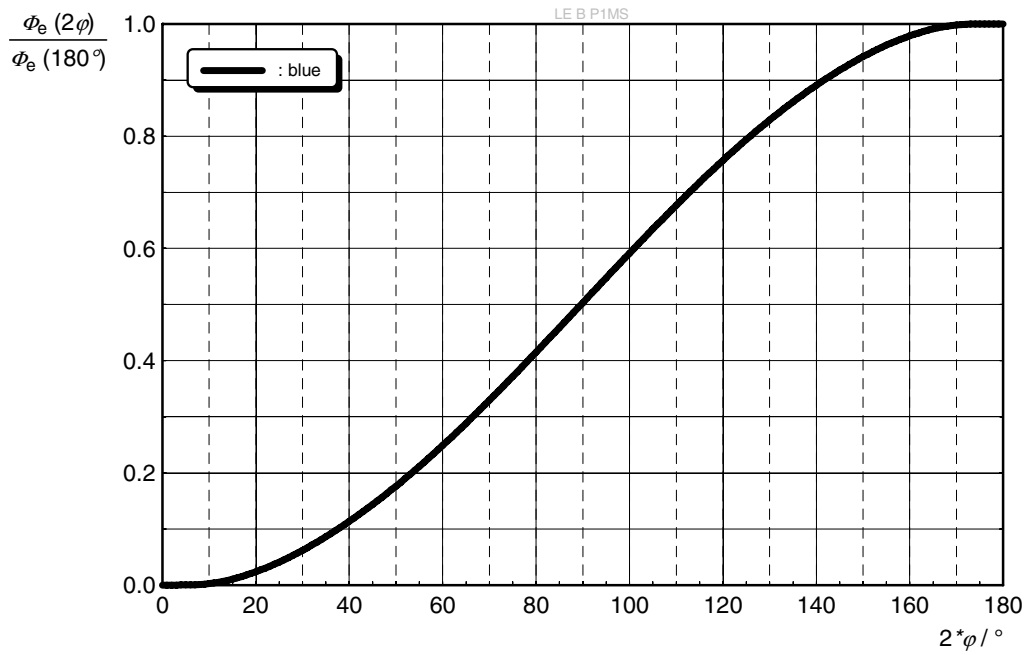
Radiation Characteristics ⁴⁾

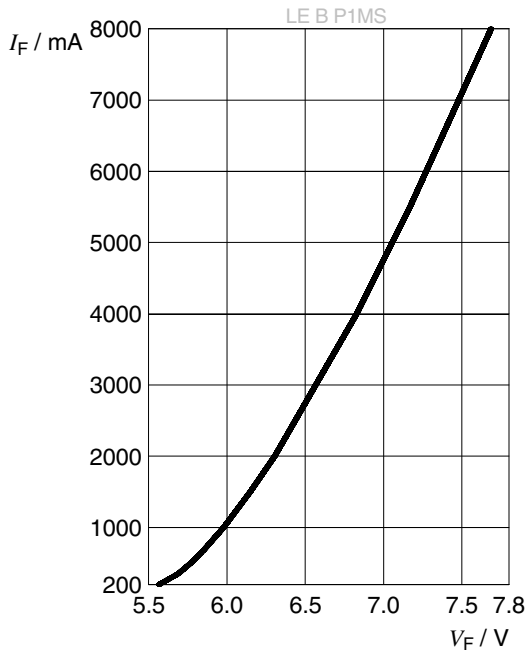

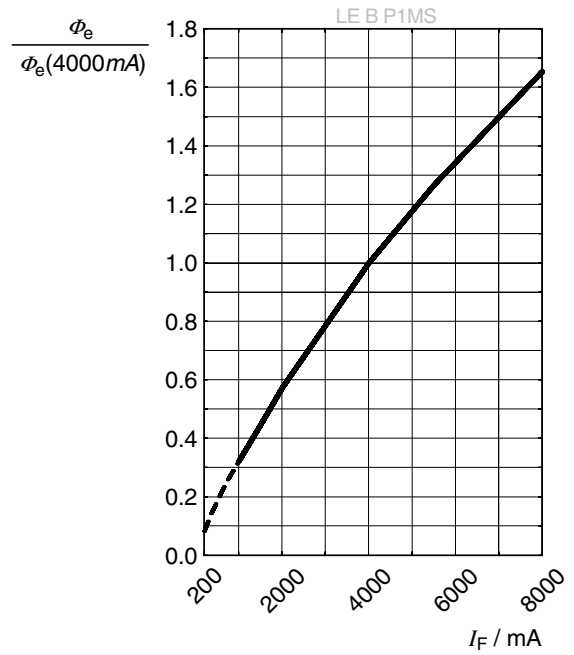

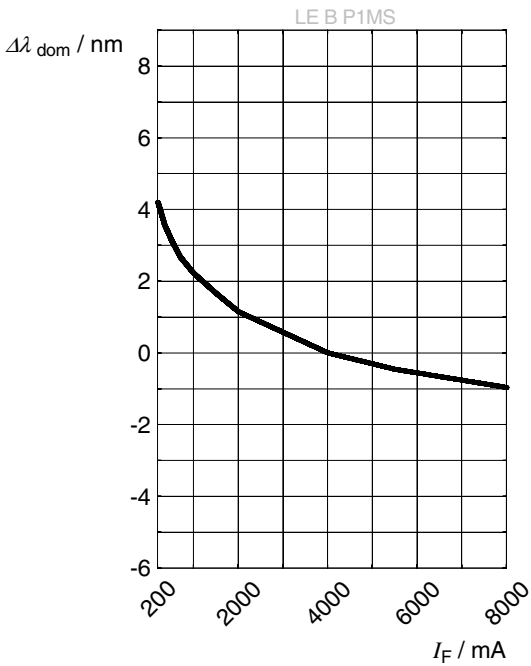

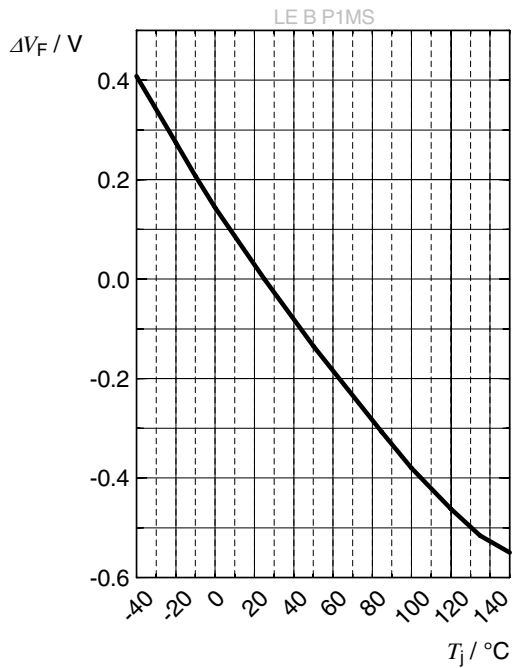

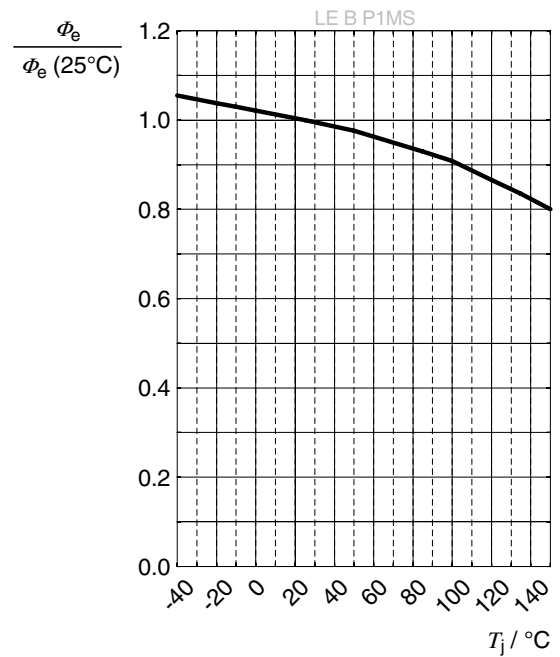

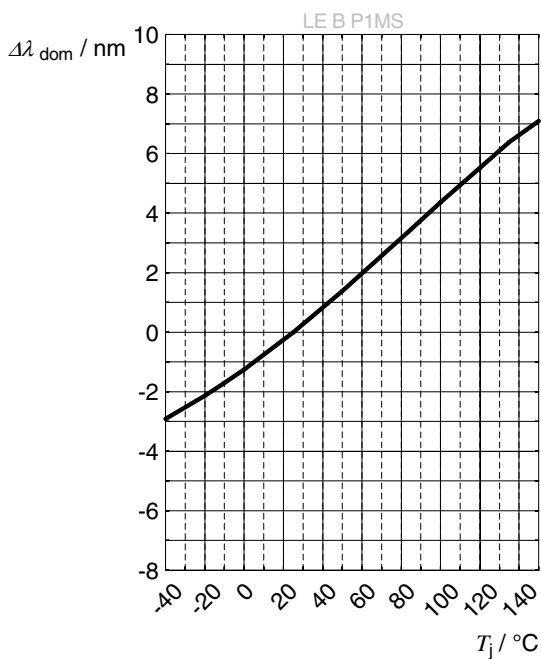

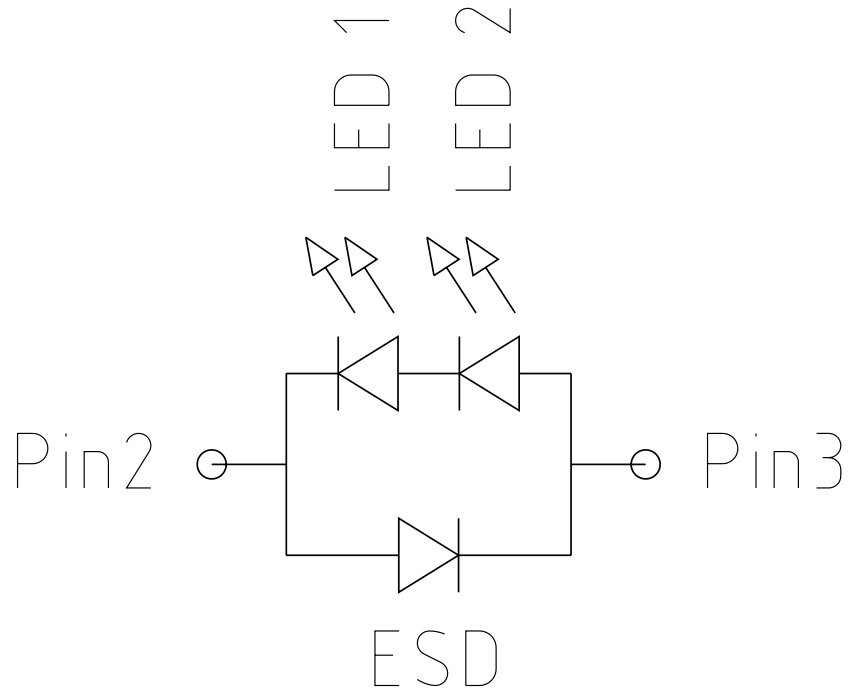

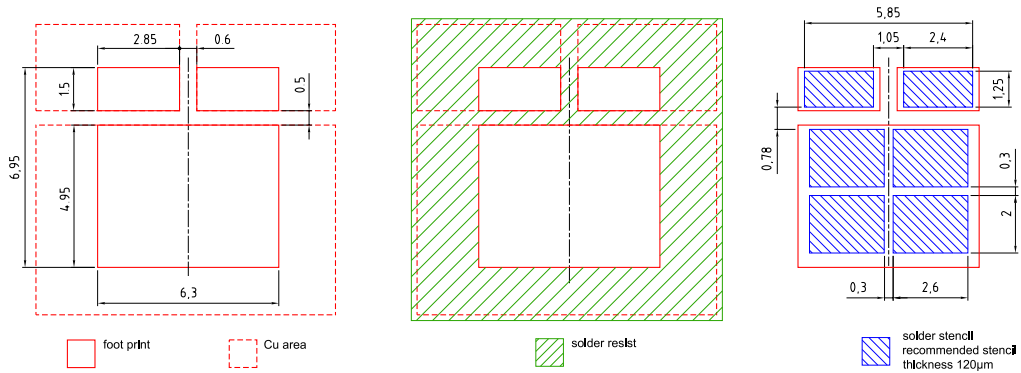

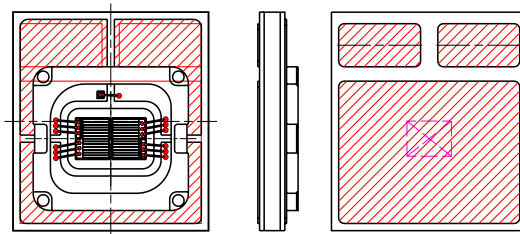
Electrical Internal Circuit

Component Location on Pad

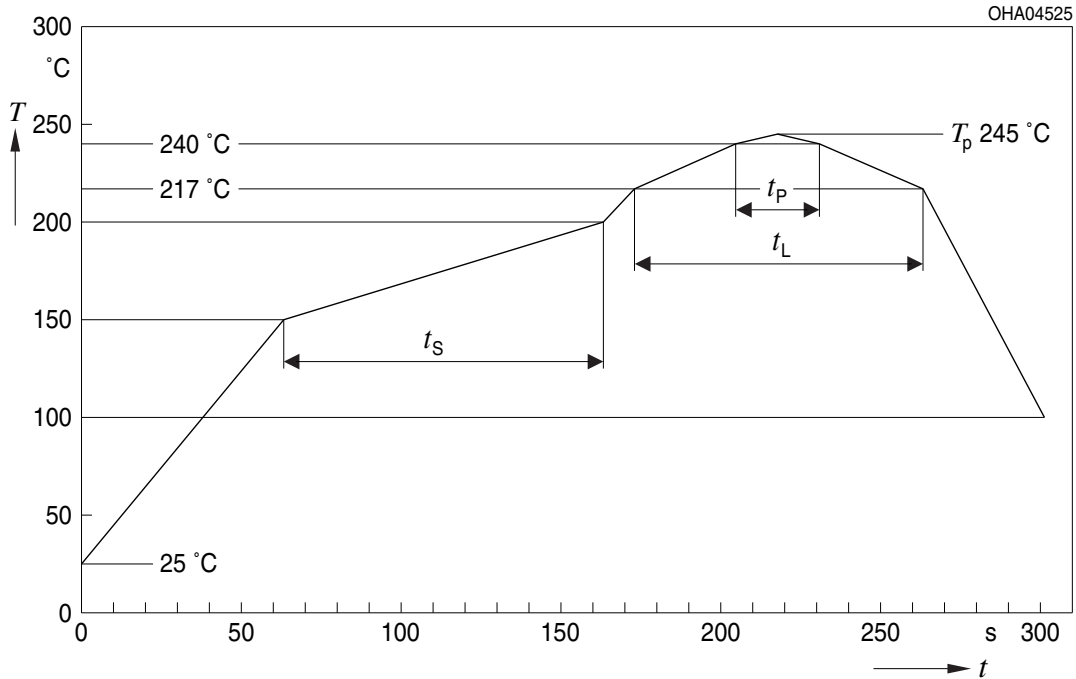

Reflow Soldering Profile

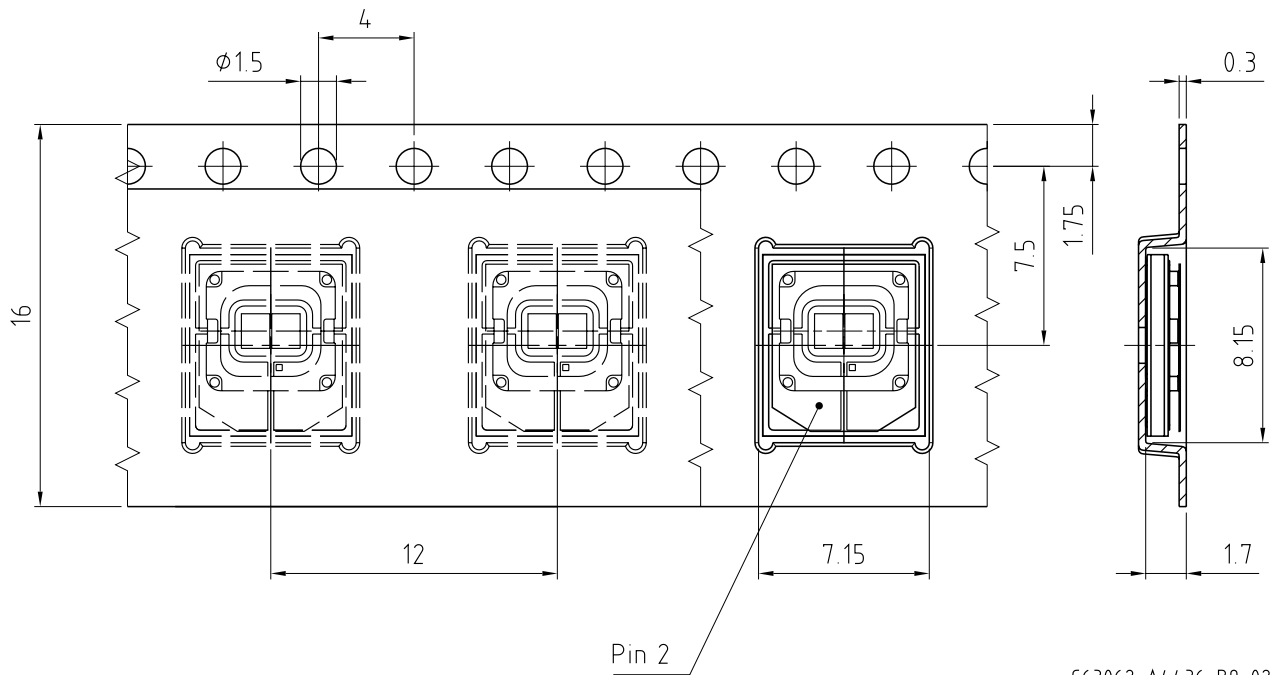

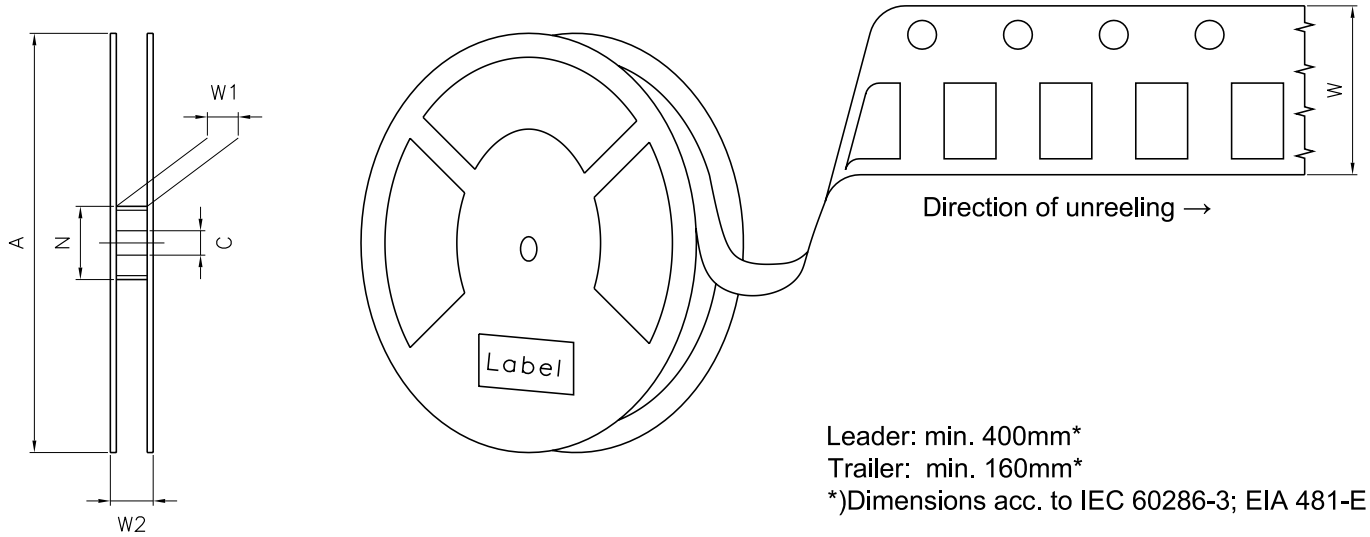

Notes

Subcomponents of this device contain, in addition to other substances, metal filled materials including silver. Metal filled materials can be affected by environments that contain traces of aggressive substances. Therefore, we recommend that customers minimize device exposure to aggressive substances during storage, production, and use. Devices that showed visible discoloration when tested using the described tests above did show no performance deviations within failure limits during the stated test duration. Respective failure limits are described in the IEC60810.

Glossary

- 1) **Brightness:** Brightness values are measured during a pulse train of 100 ms with a pulse width of 250 μ s and a frequency of 1 kHz, with an internal reproducibility of \pm 8 % and an expanded uncertainty of \pm 11 % (acc. to GUM with a coverage factor of $k = 3$). The peak brightness is calculated according to the pulse duration and frequency.
- 2) **Reverse Operation:** This product is intended to be operated applying a forward current within the specified range. Applying any continuous reverse bias or forward bias below the voltage range of light emission shall be avoided because it may cause migration which can change the electro-optical characteristics or damage the LED.
- 3) **Wavelength:** The wavelength is measured during a pulse train of 100 ms with a pulse width of 250 μ s and a frequency of 1 kHz, with an internal reproducibility of \pm 0,5 nm and an expanded uncertainty of \pm 1 nm (acc. to GUM with a coverage factor of $k=3$).
- 4) **Typical Values:** Due to the special conditions of the manufacturing processes of semiconductor devices, the typical data or calculated correlations of technical parameters can only reflect statistical figures. These do not necessarily correspond to the actual parameters of each single product, which could differ from the typical data and calculated correlations or the typical characteristic line. If requested, e.g. because of technical improvements, these typ. data will be changed without any further notice.
- 5) **Forward Voltage:** The forward voltage is measured during a pulse of typical 250 μ s, with an internal reproducibility of \pm 0,05 V and an expanded uncertainty of \pm 0,1 V (acc. to GUM with a coverage factor of $k=3$).
- 6) **Characteristic curve:** In the range where the line of the graph is broken, you must expect higher differences between single devices within one packing unit.
- 7) **Tolerance of Measure:** Unless otherwise noted in drawing, tolerances are specified with \pm 0.1 and dimensions are specified in mm.
- 8) **Tape and Reel:** All dimensions and tolerances are specified acc. IEC 60286-3 and specified in mm.
