




Relative Spectral Emission⁴⁾

Radiation Characteristics⁴⁾




Relative Partial Flux⁴⁾

Relative cumulated Luminous Flux ⁴⁾




Chromaticity Coordinate Shift ⁴⁾






Forward Voltage ⁴⁾



Relative Luminous Flux⁴⁾






Electrical Internal Circuit



Notes

The peak brightness is calculated according to the pulse duration and frequency.
- ²⁾ Reverse Operation: This product is intended to be operated applying a forward current within the specified range. Applying any continuous reverse bias or forward bias below the voltage range of light emission shall be avoided because it may cause migration which can change the electro-optical characteristics or damage the LED.
- ³⁾ Chromaticity coordinate groups: Chromaticity coordinates are measured during a pulse train of 100 ms with a pulse width of 500 μ s and a frequencey of 1 kHz , with an internal reproducibility of +/- 0,005 and an expanded uncertainty of +/- 0,01 (acc. to GUM with a coverage factor of k = 3).
- ⁴⁾ Typical Values: Due to the special conditions of the manufacturing processes of semiconductor devices, the typical data or calculated correlations of technical parameters can only reflect statistical figures.
