Description for Product Change Notification

Starting immediately, there is a running change on the WML family of labels (self-laminating wire wraps). The labels have been rotated 180 degrees on the liner so that the transparent "tail" emerges first through the printer. This was done to eliminate the problem of the "black line" that would remain if the printer was not running and the print head was left closed for any length of time.

IMPORTANT: To use this new format of labels, you must select the correct material file within Clip Project. You must be using Clip Project marking 8.7 and choose WML..._180 (see screen shot below).

In addition to the rotation change, the color of the printable area was lightened such that the print quality using the standard THERMOMARK-RIBBON 110 (5145384) has improved. All the other technical parameters – such as temperature range and UL 969 – remain unchanged.

Along with this PCN document, is an Excel file listing the part numbers affected and the version code (V/C) that has the rotated format. The V/C is found on the label on the outside of the plastic packaging container. Please keep this container for all roll materials when calling for support form Technical Service.




