DESCRIPTION

The SD008-2151-112 is a GaN UVA photodiode with a 0.076 mm² active area. Unlike most UV detectors it cuts off unwanted visible light from its detection spectrum (220-370nm), thereby eliminating the need for optical filter. Photodiode is assembled in a hermetic TO-46 package.








> UV-A Photocurrent



> UV-I Photocurrent




> Noise vs. Bias
