

TPD6E05U06RVZ

The TPD6E05U06 is an ESD protection device with ultra low capacitance. This device is constructed with a central ESD clamp with two hiding diodes to reduce the capacitive loading. It is rated to dissipate ESD strikes above the maximum level specified in the IEC61000-4-2 level 4 international standard. Its ultra low loading capacitance makes it ideal for protecting any high-speed signal pins.

2 EVM Description and Configuration

The TPD6E05U06RVZEVM is designed to allow 4-port analysis through a 100 Ω TMDS line, or differential pair. The board material is Rogers Board RO4350 with a Dielectric Constant, ϵr , of 3.48 \pm 0.05 and a loss tangent, δ , of 0.0031 at 2.5 GHz. The port connectors are surface-mount SMP 50 Ω high speed connectors.

The EVM has two sections: CALIBRATION and TPD6E05U06RVZ. The traces on the CALIBRATION section are identical to the traces on the TPD6E05U06RVZ section, allowing the board's effect to be removed and only the device under test's performance to be evaluated, without having to de-solder the device under test.








