


Illustration: How to predict components temperature






Relative Spectral Distribution

• Relative Spectral Distribution vs. Wavelength






• Scale ratio curve for related lumen output VS driving current, $T_c = 25 \text{ °C}$





CIE Chromaticity Diagram (Warm white), T_c = 25 °C


