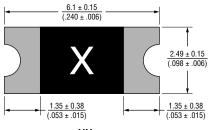

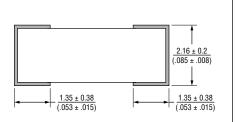

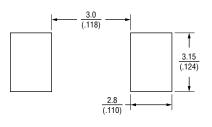

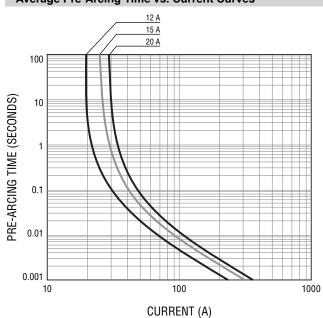


Recommended Pad Layout

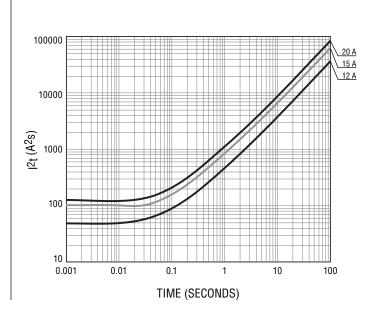

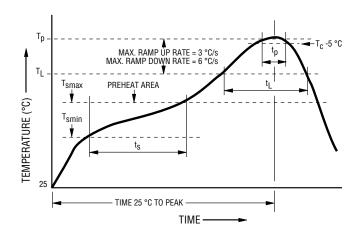

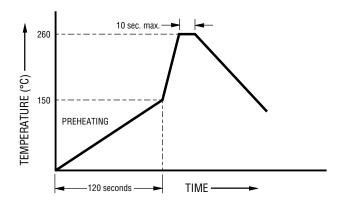
