3. Customer Impact and Recommended Action

1. The affected module products will be certified according to regulatory requirements, and the integrated equipment will need to be re-certified according to regulatory requirements.
2. If the integrated device references the module's network security solution, the feasibility of referencing the data and the scope of testing must be assessed based on the declaration and the capabilities of the integrated device.
3. After August 1, 2025, Quectel will no longer ship modules with the pre-upgrade firmware version, in compliance with regulatory requirements.
