| | As per Yageo communication dated Feb05th, and updated Feb13th 2025 and Apr07th 2025 Mylar Specialty Films Luxembourg S.à.r.l. announced their intention to shut down Films' production on Line 5 in Luxembourg. Mylar has communicated that they expect this facility to continue operating until mid-2025 and have requested that final orders be placed no later than February 28th, 2025. The affected above products reported in the attached Annex1, 2 and 3 will be affected by the Mylar line 5 shut down, which is the supplier of Film for all these parts.
