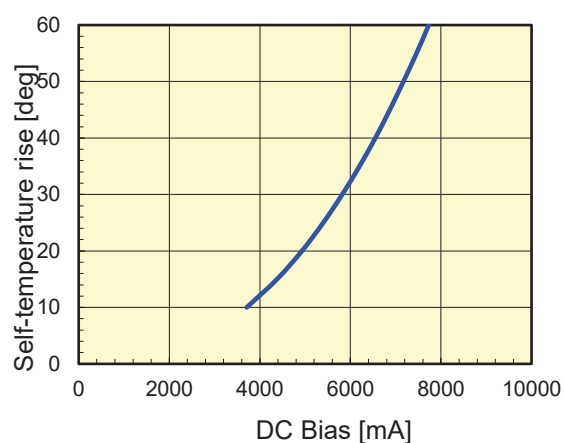

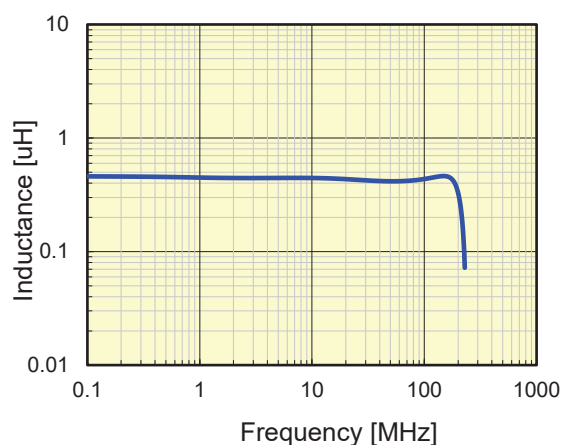
DC Bias vs Inductance
